Airport Capital Improvement Plan

SUBJECT: TEMPORARILY SUSPEND ISSUANCE OF DOOR-TO-DOOR SOLICTOR LICENSES

DATE: APRIL 2, 2020

Through the City Clerk listserv there has been discussion about temporarily suspending the issuance of licenses for door-to-door solicitations. In our effort to support to the stay-at-home order and social distancing guidelines, we ask for approval to suspend the issuance of licenses for door-to-door solicitors until the stay-at-home order is lifted or expired or other guidance is given. Currently there are no active door-to-door licenses that have been issued, but as the warmer weather approaches, we expect to see applications submitted.

Applications for other license types will be reviewed on a case-by-case basis to determine if they qualify as an essential function under the Governor's order and if they should be issued at that time.

Re: Sale of Excess Dogwood Capacity

The document you have before you is an agreement with Kansas Municipal Energy Agency (KMEA) to sell a portion of our Dogwood product back to KMEA who will in turn move it back into the Dogwood facility portfolio.

As you can see in the chart on page 2 of the confirmation, this transaction only applies to what are commonly referred to as shoulder months. A time when loads are typically lower and allows for capacity to be moved where it is most beneficial across the Westar footprint. We are a small portion of a larger purchase by Dogwood which includes nearly all KMEA members who will be compensated at the rates shown in the chart. These numbers reflect a firm price that is above market value. This allows a short-term purchase of capacity from the market in the event we experience some unforeseen increase in current load predictions. This is in the true sense of the phrase "working together" to create benefit for all parties involved. Your action at today's Study Session is kindly requested so that I may process the document in time for the KMEA executive committee meeting on April 15th.

Any inconsistency between this Confirmation and the Governing Agreement shall be resolved in favor of this Confirmation. Terms used but not defined herein shall

have the meanings ascribed to them in the Governing Agreement.
